The recent APCO Conference was a great success. Two Memphis Communication employees received their RPL designations during a ceremony.

- APPLE iOS 12 & RAPIDSOS:

Apple released iOS12. When downloaded Apple phones, with iOS12, will send fast and accurate device location information to the RapidSOS NG911 clearinghouse when a user dials 9-1-1. A demonstration of Vesta Map Local will be shown after the meeting in the computer lab. Carlton Ray and Timothy Zimmer will demonstrate and explain how the system operates.

- Connecting Our PSAPs to the State of Tennessee ESINET:

We recently met with representatives from Motorola, AT&T, Comtech, the State of Tennessee Emergency Communications Board in Memphis to discuss the plans and document responsibilities for connecting Shelby County PSAPs to the States NG911 ESINet network. Note also the State 9-1-1 board recently voted to migrate to the A&T Nationwide ESINet network

- Shelby County ECD - TEXT to 9-1-1:

AT&T has advised they will pay our costs to obtain "Text to 9-1-1" (TXT29-1-1) for Shelby County during discussions with AT&T during the APCO conference.

- Motorola VESTA 7.X and VESTA Map Local at remaining PSAPS:

We have the approximate cost to upgrade our remaining PSAPs in Shelby County to Vesta 7.x and install Vesta Map Local in each PSAP at \$2,450,000. This will also provide the full integration to RapidSOS Clearinghouse. These funds are included in the current FY18-19 budget. This will make our remaining PSAPs identical to the Memphis Police and Fire PSAPs.
