# SHELBY COUNTY EMERGENCY COMMUNICATIONS DISTRICT Board of Directors Meeting Minutes February 3, 2022

The following are the minutes from the Board of Directors meeting of the Shelby County Emergency Communications District ("Shelby County 911") held on February 3, 2022, by electronic means per TCA 8-44-108.

#### Roll Call

The meeting was called to order by Chair Anderson at 8:32 a.m. Chair Anderson began a roll call of the Board members. Finding a quorum present, the meeting commenced.

#### Review and Approval of December 2, 2021, Full Board Minutes

Chair Anderson confirmed everyone had the opportunity to review the minutes from the full Board meeting on December 2, 2021; she then requested a motion to accept the minutes from the full Board meeting.

Director Kramer offered a motion to accept the full board meeting minutes from December 2, 2021.

Director Cash seconded the motion to accept the minutes from the full Board meeting on December 2, 2021.

The Board voted 6-0 via roll call to accept the minutes from the full Board meeting on December 2, 2021.

#### **Treasurer's Report**

Chair Anderson advanced the agenda to the next item for consideration: A review of the Treasurer's Report presented by Director Kneeland.

# • Financial Report

Director Kneeland presented a review of the current fiscal year revenue and expenses for the period July 1, 2021, through June 30, 2022, as follows:

- \$ 5.464 million total year-to-date revenue,
- \$ 4.494 million total year-to-date expenses,
- \$ 970 thousand total year-to-date income.

# Fund Balances and Investments

Director Kneeland presented a review of the Working Capital Accounts and Reserve Fund Account as of November 30, 2021, as follows:

- Charles Schwab Working Capital Investment Fund \$11.481 million total
- First Horizon Checking Account \$10.669 million total
- Charles Schwab Reserve Fund Account \$23.026 million total

Director Kneeland advised that Charles Schwab documents are included to reflect account information.

Chair Anderson requested a motion to accept the financial report as presented by Director Kneeland.

Director Shull offered a motion to accept the financial report as presented by Director Kneeland.

Director Carter seconded the motion to accept the financial report as presented by Director Kneeland.

The Board voted 6-0 via electronic roll call to accept the financial report as presented by Director Kneeland.

#### **Directors Report**

Chair Anderson advanced the agenda to the next item for consideration: A review of the Director's Report presented by Director Chiozza.

Director Chiozza provided highlights on the following:

#### • Audit Review, June 30, 2021

Since we are a component of Shelby County Government, the board approved the final draft of the audit during the December meeting to be included with Shelby County Government. Watkins Uiberall representatives provided a review of the June 30, 2021, audit and a link to the final Audit and Governance Letter was included.

Chair Anderson requested a motion to accept the audit review as presented by Watkins Uiberall.

Director Love offered a motion to accept the audit review as presented by Watkins Uiberall.

Director Kramer seconded the motion to accept the audit review as presented by Watkins Uiberall.

The Board voted 7-0 via electronic roll call to accept the audit review as presented by Watkins Uiberall.

### • Bartlett and Germantown Construction Contracts

The contracts are being reviewed by the Board's general counsel. Mike Marshall advised that some exhibits are still in review in hopes of final drafts this month. A development agreement is being drafted for Bartlett and Germantown PSAPs. Links to Agreement Owner and Architect were included in the documents for review by the board.

#### • SCSO/SCFD PSAP Projects

Mike Deatherage, Administrator of SCSO requested assistance in getting the land approved. The delay is related to obtaining the land survey which is needed to create a legal description of the parcel that will facilitate an agreement with the Shelby County 9-1-1 District. Fleming Architect is assisting in obtaining the cost for the land survey to expedite the process.

# • Motorola Smart Transcription and Citizen Input

Motorola will begin installation for the remaining PSAPs around February 14, 2022. Smart Transcription and Citizen Input has been installed at the Germantown PSAP.

#### • Lenox Lease

The Lease for office space has been signed for the period of January 1, 2022, through May 31, 2027. A link was provided to the board for review.

#### • 2022 Legislative Session

Bill number is SB1975 deals with funding of 9-1-1. This may be a way to get rid of the Section 130 (excess funds) funding the State 9-1-1 board distributes but I am not sure at this time. I am waiting further information from our lobbyist. A link was provided for SB1975.

HB2473 by Bricken and SB2384 by Gardenshire was filed February 1, 2022.

As introduced, requires ECDs to utilize the direct dispatch method in response to emergency 911 calls and one of three methods in response to non-emergency calls; requires that all emergency 911 calls, with the exception of misrouted calls, be dispatched without being transferred; authorizes ECDs to transfer non-emergency calls at the discretion of the dispatcher via attended transfer; adds emergency call takers and public safety dispatchers and emergency services personnel to definition of first responder for certain purposes.

Each Municipality should advise their leaders of SECTION 5 shown below. This could affect your municipality later down the road even though you already do Direct Dispatch but maintain your right to dispatch your own public safety services.

As I have stated before I am not opposed to the Direct Dispatch per say but I think we may need more than three years for the effected agencies to cross train all the employees and get the actual centers ready. Our deadline would be July 1, 2025, to accomplish this. Getting the new PSAP building built for the Sherriff's Office and County Fire may take years at the pace we are currently going. This is why I say it would be nice to have more time.

SECTION 5. Tennessee Code Annotated, Section 7-86-107(b), is amended by deleting the language "the right to dispatch its own services" and substituting instead the language "the right to dispatch its own non-emergency services".

(g) Emergency 911 calls must be dispatched by the initial public service answering point without being transferred. A link was provided for HB2473.

# • Shelby County Sheriff's Office CAD Upgrade

Mission Critical Partners has been working with the Shelby County Sheriff's Office since April 2021, meeting with Motorola on a CAD upgrade. The County needs to move to the most current Motorola CAD P1 version to be fully supported by Motorola. At present Motorola is no longer supporting the version that the County CAD currently has, and thus is advising the County that they cannot guarantee the ability to respond to and mitigate any software performance issues that may arise. The Sheriff's CAD system will remain at risk (and increasing risk) if they stay on the current CAD version that is not fully supported by Motorola.

• Network Systems Engineer and GIS Engineer Positions Search
On January 18, 2022, we contracted to exclusively engage the Executive Search services
of APCO to conduct an executive search on behalf of the Shelby County ECD for
applicants for the positions of Network Systems Engineer and GIS Engineer.

The board had previously approved \$45,000 for one position but since we chose to use the APCO Executive Search, the cost will be \$20,000 per position, so it will cost the district \$40,000 for both positions.
